

## Data protection information on video monitoring in accordance with Article 13 GDPR

### Information on the processing of personal data collected in the context of video surveillance of facilities (including the place of work) and the surroundings of the facilities of AmRest Group companies.

#### INTRODUCTION

In accordance with Regulation (EU) 2016/679 of the European Parliament and of the Council of April 27, 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation), we would like to inform you that

1. The controller of your personal data is the respective AmRest Group company that owns the facility or office space (hereinafter: "AmRest" or "We").
2. Any questions, comments or requests regarding the processing of your personal data are welcome and should be sent to the Data Protection Officer by e-mail: or by post to the address indicated in the table below.
3. This information clause describes how we collect and process your personal data in connection with our video surveillance (CCTV) and informs you of your rights in accordance with the provisions of the General Data Protection Regulation (GDPR).
4. In the following table you will find details of the data controller.

#### I. WHAT INFORMATION DO WE COLLECT?

We may collect, store and process some or all of the personal data listed below:

- (a) The image of persons in the video monitoring area;
- (b) Also information about the behavior during the stay in the video monitoring area.

#### II. HOW IS THE DATA COLLECTED?

We collect all personal data directly from you. The provision by you of the personal data collected in the course of monitoring is not a legal or contractual obligation and is not a condition for the conclusion of a contract. The provision of all data is voluntary. The data is collected automatically through the recording of your image by the monitoring system.

#### III. HOW DO WE PROCESS PERSONAL DATA?

Your personal data will be processed for the following purposes:

AmRest carries out video surveillance of AmRest facilities (e.g. office and restaurants, including the place of work) and processes your personal data to ensure the safety of persons, including employees, and to protect AmRest's assets by preventing criminal offenses such as vandalism, burglary, theft, robbery, assault, threats (cameras in the checkout area), clarification of criminal offenses, assertion of claims for damages, order processing, food safety or exercise of domiciliary rights. The legal basis for carrying out the monitoring and the associated processing of personal data is AmRest's legitimate interest (Article 6 (1) (f) GDPR). The monitoring of employees is additionally carried out on the basis of the national regulations applicable in a particular country.

#### IV. TO WHOM MAY WE TRANSFER YOUR PERSONAL DATA?

In addition to AmRest employees, your data collected in the context of video surveillance is also available to persons and companies responsible for the maintenance, control and support of the surveillance system and security services.

The records from the monitoring may also be made available to AmRest's insurance companies, law enforcement agencies, public authorities, including courts, and persons assisting AmRest in providing legal advice. **V. HOW LONG WILL WE PROCESS YOUR PERSONAL DATA?**

AmRest shall retain the video surveillance recordings for a period not exceeding the days specified in the table below, unless the video surveillance data serves as evidence in proceedings conducted on the basis of the law or AmRest becomes aware that it could serve as evidence in the proceedings - in which case the retention period shall be extended until the legally binding conclusion of the proceedings.

**VI. YOUR RIGHTS UNDER DATA PROTECTION LAW**

You have the right to access and rectify your personal data, obtain a copy of your personal data, erase it, restrict its processing and object to the processing of your data.

If you wish to exercise any of the above rights, please contact us using the contact details for your country in the table below. We would like to draw your attention to this:

- a) You will not have to pay a fee to access your personal data (or to exercise any of your other rights). However, we may charge a reasonable fee if your request is clearly unreasonable, repetitive or excessive. Alternatively, we may refuse to comply with your request in such circumstances;
- b) We may request additional information from you to help us confirm your identity and ensure that you have the right to access your personal data (or to exercise any of your other rights). This is a security measure to ensure that your personal data is not disclosed to any person who has no right to receive it. We may also contact you to ask you for additional information in relation to your request to speed up our response;
- c) We aim to respond to all inquiries within one month. For particularly complex requests, it may occasionally take longer than a month. In this case, we will notify you and keep you informed of the progress of the matter;
- d) In certain circumstances, we may need to restrict the exercise of the data subject's rights, for example if data is to be deleted that must be retained for legal or regulatory reasons, or if compliance with the request could jeopardize the personal data of another data subject.

You have the right to lodge a complaint with your local supervisory authority at any time. We recommend that you contact us first so that we can clarify any problems or questions you may have.

**VII. AUTOMATED DECISION MAKING AND PROFILING**

We do not carry out automated decision-making or profiling. A human being will always be involved in this process.

**VIII. CHANGES TO THE DATA PROTECTION INFORMATION ON VIDEO SURVEILLANCE**

In the event of changes to the procedure or this data protection information on video surveillance, we will inform you of the changes immediately.
