**Independent registered auditor's report  
on the review of the condensed interim financial statements  
for the period from 1 January to 30 June 2015  
To the Shareholders and the Supervisory Board  
of AmRest Holdings Societas Europaea**

We have reviewed the accompanying condensed interim financial statements of AmRest Holdings Societas Europaea (hereinafter called the Company), with its registered office in Wrocław, Pl. Grunwaldzki 25-27, comprising the interim statement of financial position as at 30 June 2015, the interim income statement, the interim statement of comprehensive income, the interim statement of changes in equity, the interim statement of cash flows for the period from 1 January to 30 June 2015 and explanatory notes.

The Company's Management Board is responsible for the preparation of condensed interim financial statements which comply with the International Financial Reporting Standards adopted by the European Union concerning interim reporting (IAS 34). Our responsibility was to issue a report on these condensed interim financial statements based on our review.

We conducted our review in accordance with the requirements of the national standards of auditing issued by the National Chamber of Registered Auditors. These standards require us to plan and perform the review to obtain moderate assurance that the condensed interim financial statements are free of material misstatements. We conducted the review mainly by analyzing the data in the financial statements, inspecting the accounting records, and making use of information obtained from the Company's Management Board and persons responsible for financial and accounting matters in the Company.

The scope and methodology of the review of condensed interim financial statements is significantly different from the scope of an audit aimed at expressing an opinion on compliance of the financial statements with the applicable accounting policies and their fairness and clarity, therefore we cannot express an opinion on the attached financial statements.
